## Holiday Market Guidelines & Information

Mail or email three close-up images of artwork with your registration form by **Saturday, September 7**. Enclose a **check or money order for your registration fee: \$20, members of the Anton Art Center; and \$30, nonmembers**. Enclose a self-addressed stamped envelope if you would like your photos or CD returned.

1. All entries must be original hand-crafted work (paintings, clay, wood, glass, textile, toys, etc.) Limited edition, numbered, and signed prints are acceptable. Entries must be ready for display.
2. All work must be designed and executed by the accepted artist.
3. No kit work or commercial reproductions of any kind allowed.
4. New and innovative work and Holiday themed items are encouraged.
5. Shipped work must be received between October 8-16. Artists are responsible for shipping costs both to and from the center.
6. **COMMISSION: The Anton Art Center retains 40% commission on all sales.**
7. **SALES TAX:** The Anton Art Center collects, reports, and pays all State of MI sales tax.

8. **Processing fee: CHECKS/MONEY ORDERS:** Please make payable to the **Anton Art Center** or pay online at [www.theartcenter.org](http://www.theartcenter.org). Entries not accompanied by a registration fee are ineligible and will not receive consideration for the Holiday Market.

9. **INVENTORY PROCESS:** Please note - we will be using the Point of Sale System again this year. An Excel spreadsheet template for recording artist inventory will be provided. Accepted artists will receive forms by email in September with instructions and schedule.
10. **PROMOTION:** Holiday Market postcards will be available during receiving.

**Artist Agreement:**

I agree that the Anton Art Center shall not be responsible for any loss or damage to artwork or personal property of any kind. I release and hold harmless, the Anton Art Center, its agents and employees of any liability that may arise by damage, loss, or theft while said work is presented in **Holiday Market 2019**. The vendor represents that he/she/it is unaware and without notice of any claims for alleged wrongful use or sale of third party intellectual property and agrees to indemnify and hold harmless the AAC, its officers, agents, and employees from liability of any kind, including the obligation to defend (if expressly requested by the AAC), as well as the cost of attorneys' fees and expenses incurred by AAC to defend, with respect to any third party claim, action, cost or judgment for intellectual property, patent, copyright, trademark or trade secret infringement arising out of the use of, offer for sale or sale of artwork, crafts, products, equipment, materials, supplies, or services covered by this contract.
