ELIGIBILITY

Open to new and existing members in good standing of the **Lakeside Palette Club of St. Clair Shores, Mount Clemens Art Association, and Warren Tri County Fine Arts Association, Inc.** Juried by artist Sharon Will. *Artworks must be original and completed within the last two years. All works previously displayed at the Anton Art Center are ineligible.* Our shared theme for this show is inspired by the *Bitter/Sweet: Coffee, Tea & Chocolate* exhibit, featured at the Detroit Institute of Arts November 20, 2016 – March 5, 2017 (www.dia.org).

PRESENTATION

All media are acceptable. Maximum of 40 in. in any direction including frame and 30 lb. maximum weight.

Please note:

- All entries must be ready to be safely and securely installed onto the wall, floor, or pedestal, including instructions if necessary, upon submission. *Framed work must be ready-to-hang securely by wire only. Please use gallery white mat board and appropriate weight-bearing picture wire only.*
- Any 2-D or 3-D work that requires special installation assistance must be accompanied by specific instructions and materials; a copy of this information must be delivered to gallery staff upon entry. *The Anton Art Center reserves the right to remove artwork that does not comply with standard installation and safety guidelines. Please refrain from submitting very fragile artwork or unsteady frames.*

ENTRY PROCEDURE

- \$10 Entry Fee per artist; Limit two entries PER PERSON regardless of number of group memberships
- Fill out label and secure to back- or under-side of your artwork
- Submit **completed entry form, entry fee, and labeled artwork** to the Anton Art Center on designated receiving day listed below to be eligible

AWARDS

1st, 2nd and 3rd prizes will be chosen by the juror and awarded at the Reception & Award Ceremony

SALES

The Art Center retains a 40% commission on all sales. *Note: Any artwork designated Not for Sale (NFS) must provide value upon entry for insurance purposes.*
