



## CALL FOR ENTRY

### Michigan Annual XLVII

Juror Salvador Salort-Pons  
January 25 – February 20, 2020



The 47<sup>th</sup> annual statewide fine art competition is juried by Salvador Salort-Pons, Detroit Institute of Arts Director, and hosted by Macomb County's long-standing premier arts & cultural nonprofit organization, the Anton Art Center.

### Eligibility

Michigan artists ages 18 and older are invited to submit up to two original entries completed within the last two years. Open to all media; no size restrictions. All works previously displayed at the Anton Art Center are ineligible.

### Entry Procedure

- **Take** hi-res photos of artwork; include frame, if framed. One photo per 2-D work or three photos per 3-D work. JPEG image files must not exceed 1.5MB. **Label** files as follows: Artwork Title\_First & Last Name\_Media\_Dimensions (in inches, *height x width*). **Email** images to [exhibitions@theartcenter.org](mailto:exhibitions@theartcenter.org) by deadline.
- **Complete** entry form provided (page 2). **Send** form by email, mail, fax, or deliver in person by deadline.
- Entry fee is \$25 at the member rate or \$35 for non-members - **Submit** entry fee payment by deadline via PayPal to [information@theartcenter.org](mailto:information@theartcenter.org), check payable to 'Anton Art Center', charge (VISA, MC, Discover, AmEx), or cash in person. A \$25 service charge is applied to any returned checks. Entry fee is non-refundable.

**DEADLINE:** All materials are due by the deadline, no exceptions: **Wednesday, January 8, 2020, 5:00PM EST.**

*We are now accepting submissions through the deadline. The Anton Art Center Administration Office will be closed for the holidays December 23, 2019, through January 1, 2020. The building will re-open on January 2, at 10AM.*

### Artwork Delivery Notes

Accepted artworks and artist materials (Artist Statement and/or CV) may be delivered to the Anton Art Center during the receiving date listed, unless other arrangements are made in advance. Artists are responsible for transportation and/or shipping arrangements and costs both to and from the Anton Art Center. Artwork must be unwrapped and ready to be safely and securely installed upon arrival. With the exception of shipped artwork only, we are unable to store any packaging materials. Please provide installation instructions, if applicable. The Anton Art Center reserves the right to remove work that does not comply with standard installation and safety guidelines.

### Awards

**First Prize \$1,000 • Second Prize \$600 • Third Prize \$400 • Honorable Mention Award (3)**

Awards to be decided by our guest juror, Salvador Salort-Pons.

### Sales

The price submitted is the final retail price. Must provide insurance value and note if artwork is not for sale (NFS). The Anton Art Center retains 40% of the retail price on all works sold.
